## Biographical/Historical Note

---

Born and raised in Portland, Maine, Perdita Huston spent her professional life advocating for sustainable development and sound family planning worldwide. She spent a number of years living in northern Africa and France before settling in the Washington, DC area, and continued to travel widely to conduct research and to attend international conferences. Her work included the publication of four books, (the most recent being *Families As We Are: Conversations From Around the World*, Feminist Press, 2001) which focus particularly on rural women whose voices are too often ignored by government officials and developers. Perdita Huston studied at the University of Colorado and the Universite de Grenoble, and received her BA in sociology and international relations from the Ecole des Hautes Etudes Internationales in Paris in 1958. Marriage to a French doctor brought her to Algeria during its war for independence. There, she worked as a medical social worker, beginning her life-long advocacy for people living in developing countries, especially rural women. Huston also held positions with the Tunisian Ministry of Information and the Algerian Ministry of Agriculture while living in Africa. Her professional journalism career began with *Life* magazine, for which she worked both as an administrator and as a reporter, writing freelance articles about the situation in northern Africa throughout the 1960s for *Life* and *Time*, as well as the *New York Times*. After continuing work with *Time/Life* in Europe for several years, Huston moved to Washington DC in 1971 to direct programs for the American

Revolution Bicentennial Administration, primarily programs for women. In addition to her varied journalistic work, Huston was involved with many organizations and delegations, including several United Nations agencies, the Peace Corps, and the American Revolution Bicentennial Administration. Huston's expertise lay in research (primarily personal interviews), writing significant documents, developing new programs, and coordinating media relations for organizations. In 1978, Huston became the Peace Corps Regional Director for North Africa, Near East, Asia, Pacific (NANEAP), and returned as a Country Director (Bulgaria and then Mali) in 1997. Her activities between 1981 and 1985 included a wide variety of work, including serving as a Scholar-in-Residence for two years at Wheaton College, researching and producing a documentary film (African Recovery) and consulting on public affairs for the InterAction Council, an independent group of 30 former Heads of Government. Other positions included coordinating the Population and Sustainable Development Program for the World Conservation Union (IUCN) and serving as Director of Public Affairs for the International Planned Parenthood Federation (IPPF). Huston's books are largely based on independent research and travel, but highly connected to her work with international organizations. All of the books deal largely with the state of families and the status of women worldwide. To research her first two books, *Message from the Village* (Epoch B, 1978) and *Third World Women Speak Out* (Overseas Development Council, 1979), Huston traveled to six developing countries. Huston continued to focus on the changing nature of families world-throughout the mid-1990s, as a part of her Global Family Project, publishing *Families As We Are* (Feminist Press) in 2001. Throughout her career, Huston was highly involved in local and international conferences on the topics of women's rights, sustainable development, and media ethics. Because of her extensive experience, energy and optimism, Huston was a highly sought-after speaker and was a regular featured lecturer on university campuses and other educational settings. She was widely recognized for her contributions in the area of human rights. She received honorary degrees from Wheaton College (1980) and Southeastern Massachusetts University (1983) and was the first recipient of the Margaret Mead World Citizen Award in 1980. Her dozens of organizational affiliations include Amnesty International (Board of Directors, 1982-87), the Jordan Society (Trustee, 1981-87) and the U.S. Committee for UNICEF (Member, 1981-86). Huston passed away in 2001 at the age of 65, and the United Nations Association for the National Capital Area has created the "Perdita Huston Human Rights Fund" in her honor. She is survived by her three children, Françoise Champey Pommier, Jeanne Marie Champey Paynel, and Pierre Marc Diennet, of Bethesda, Maryland, San Diego, California, and Brooklyn, New York, respectively.

#### Scope and Contents

This series is divided into three sub-series which represent Huston's major writing projects. The first includes primarily notes, drafts, and correspondence relating to her written work from the years 1963-1995. Projects of note include her responses to a 1982 human rights mission to the Middle East, files from her work on the documentary film "African Recovery", and material relating to the United Nations Fourth World Conference on Women (1994), for which she was a delegate and drafted a number of documents. The following two series contains extensive research material for her first three books, Message from the Village, Third World Women Speak Out, and Motherhood By Choice (released in The United Kingdom as The Right to Choose by Earthscan). Included is travel information, complete transcripts of her interviews, publication material, reviews and reader responses to the drafts and finished works.

## Work with organizations, 1972-1999

Physical Description: 3 linear feet

### Scope and Contents

This series includes material and files from organizations that Huston directed, worked for, or was involved with as a trustee or member. There are three sub-series dedicated to her work as Director of Women's Programs for the American Revolution Bicentennial Administration (1972-1976), Regional and Country Director the Peace Corps (1978-1981 and 1997-2001), and Assistant to the Administrator of the InterAction Council (1984-1985). Included is background information, working papers and drafts, inter-agency memos and briefings, letters from supportive individuals and groups, Huston's personal files, press dossiers and clippings. Most of the Peace Corps material documents research and interviews with government leaders conducted by Huston for the 20th anniversary of that organization. There is also a sub-series documenting Huston's work with several organizations over the years 1978-1996, the bulk of the files representing her work with the IUCN from 1987-1988.
